



# EDGE 2 REBATE PROGRAM

Through December 31, 2024 receive special savings when you upgrade your existing EDGE 1 main controllers and remote displays to the EDGE 2.

## PROGRAM DETAILS

### ***\*Receive credit on the return of the following EDGE 1 components:***

- KEDG-MC-P-X (EDGE PRO MAIN CONTROLLER W/ X ROOM SW LICENSE, KIT) (*X denotes the number of production rooms on the main controller.*)
- KEDG-MC-P-1 (EDGE PRO MAIN CONTROLLER W/ 1 ROOM SW LICENSE, KIT)
- KEDG-P-RMT-DSP (EDGE PRO REMOTE DISPLAY, SYSTEM)

### ***Use your credit on the following EDGE 2 controls and displays:***

- EDG2-MC-RETRO (EDGE 2, MAIN CONTROLLER RETRO)  
*Existing software licenses will be transferred at no charge to the EDGE 2 platform during this program.*
- EDG2-RD-RETRO (EDGE 2, REMOTE DISPLAY RETRO)

Components for upgrade will be purchased at normal dealer pricing. Licenses will be transferred at no charge during this program timeline. Serial numbers for both EDGE 1 and EDGE 2 controllers must be available for the transfer of the software license.

EDGE 1 components must be returned through our normal RMA process for credit.

### **\*Credit will be issued to the dealer account to get the additional rebate below:**

- EDG2-MC-RETRO (EDGE 2, MAIN CONTROLLER RETRO) will receive a **34%** additional rebate.
- EDG2-RD-RETRO (EDGE 2, REMOTE DISPLAY RETRO) will receive a **34%** additional rebate.

Additional power supplies may be required depending on site configuration, contact your DM to discuss details.

Orders for upgrade controls must be placed by **December 31, 2024**.

Returns of EDGE 1 upgraded controls must be received no later than **March 1, 2025**.

Controls returned must be complete (no parts removed for spare parts).

Rebate program is not retroactive and begins on January 1, 2023.

AP reserves the right to change or cancel this program at any time.

EDGE 2 Rebate Program is only valid in the USA.

## ORDER & CREDIT PROCESSING DETAILS

---

### ORDER PROCESSING

- All orders for controls tied to the rebate program for credit are to be placed with Mary Denton [mary.denton@agcocorp.com](mailto:mary.denton@agcocorp.com), direct line 217-820-1170.
- Orders for controls that will result in program credits must be placed no later than December 31, 2024.
- An RMA for the EDGE 1 controls being returned will be issued when the order is placed.
- The number of EDGE 2 components ordered must be equal to the number of controls being returned on the associated RMA.
- Controls will be sold at list price in effect at time of order and standard dealer discount and terms.
- The program cannot be combined with any other standard discount programs.
- Labor is not included in the program and will be paid by the end user.
- EDGE programming fees will be an additional cost if on site assistance is required by the end user or dealer.
- Additional power supplies may be required for main controllers and remote displays depending on the site layout.

### RETURN/CREDIT PROCESSING

- EDGE 1 hardware being returned for credit must be sent to:

- The RMA number issued at the time that the replacement controls were ordered must be clearly marked on the return packaging.
- Controls returned for credit do not have to be functioning but must be complete, no missing components. The credit will not be issued if parts have been removed from the control.
- The invoice for the sale of the EDGE 2 controls used to upgrade EDGE 1 controls being returned must be paid in full before credit can be issued.
- Returns of qualified EDGE 1 controls must be received no later than March 1, 2025.
